Boat excise tax must be paid by a resident to the tax collector of their town before renewing a boat registration. A nonresident must pay excise tax to the Maine town where the boat is primarily moored, docked, stored or located prior to registering their boat if the boat is in Maine more than 75 days during a calendar year. If the boat is exempt from excise tax, a tax exemption form must be completed by the owner and submitted with registration application and registration fee. No excise tax is due on a snowmobile or an ATV. Registration fees – make checks payable to Treasurer State of Maine (the fees below includes \$1.00 agent fee)
